**WINDSHIELD STICKERS:** Must be filled out and firmly attached to lower driver side windshield.  
**GENERATORS/NOISE:** Excessive stereo/display noise not allowed. No generators from 10 pm to 5 am. Fire extinguisher required with generator.  
**SECURITY, LIABILITY, PROPERTY DAMAGE:** Security provided Thursday, Friday, and Saturday, but area is large and WPE, HAN and/or staff CANNOT assume liability for your property.
